

Terms of Service

1. Your Acceptance

A. By using and/or visiting this website (collectively, including all content and functionality available through the 59sec-video.com domain name, the "59sec-video.com Website", or "Website"), you signify your agreement to these terms and conditions (the "Terms of Service"). If you do not agree to any of these terms, please do not use the 59sec-video.com Website.

B. Although we may attempt to notify you when major changes are made to these Terms of Service, you should periodically review the most up-to-date version <http://59sec-video.com/docs/Terms-Of-Service.pdf>. 59sec-video.com may, in its sole discretion, modify or revise these Terms of Service and policies at any time, and you agree to be bound by such modifications or revisions. Nothing in this Agreement shall be deemed to confer any third-party rights or benefits.
